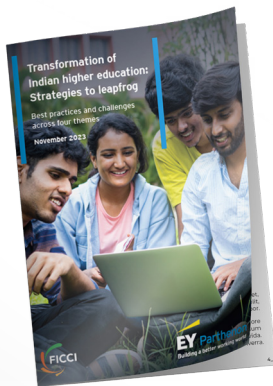
## Cancellation Policy for Registration:

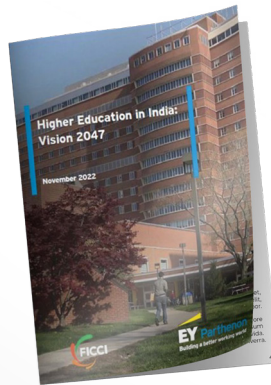

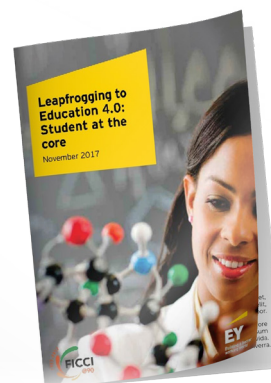
